

ORDINANCE NO. 67

AN ORDINANCE OF THE COUNTY OF GOODING, STATE OF IDAHO,
ESTABLISHING AND FIXING RULES OR PROCEDURE FOR PUBLIC HEARINGS
BEFORE THE BOARD OF COUNTY COMMISSIONERS AND ALL OTHER BOARDS
AND COMMISSIONS OF THE COUNTY AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE GOODING COUNTY COMMISSIONERS IN AND FOR
GOODING COUNTY, STATE OF IDAHO.

SECTION 1. The following rules are hereby established and shall be observed in the
conduct of any Public Hearing before the Gooding County Commissioners or any other board or
commission of the Gooding County Commissioners, and shall be known as the "Rules of
Procedure for Public Hearings."

1. No person shall be permitted to testify or speak at a public hearing, unless such
person has signed his or her name and written his or her residential address
thereafter on sign-up sheets to be provided by the County. This rule shall not
apply to staff or technical witnesses directed by the County Commissioners to
give evidence or information at the public hearing.
2. No person shall be permitted to speak at a public hearing until such person has
been recognized by the presiding officer.
3. All public hearing proceedings shall be recorded electronically or steno-
graphically and all persons speaking at such public hearings shall speak before a
microphone in such a manner as will assure that the recorded testimony or
remarks will be accurate and trustworthy.

4. At the commencement of the public hearing, the County Commissioners, board or commission may establish a time limit to be observed by all speakers. The time limit shall be established, depending on the number of speakers who sign up for each public hearing and shall apply only to the speaker's comments.
5. The speaker shall not be interrupted by members of the County Commissioners, board or commission, until his or her time limit has expired or until he or she has finished his statement.
6. At the conclusion of a speaker's comments, each member of the County Commissioners, board or commission, when recognized by the presiding officer, shall be allowed to question the speaker and the speaker shall be limited to answers to the questions asked. The question and answer period shall not be included in the speaker's time limit.
7. Any person not conforming to any of the above rules may be prohibited from speaking during a public hearing. Should any person refuse to comply with such prohibition, he may be removed from the room by order of the presiding officer.
8. The presiding officer shall have the authority to interpret and apply the foregoing rules, subject to an appeal to the County Commissioners, board or commission, which decision shall be determined by a majority vote of the members present.

SECTION 2. All ordinances, resolution, rules and policies in conflict with this ordinance are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect, from and after its passage, approval and publication.
