

REGULAR SESSION, March 9, 2026

Commissioner Bolduc opened the meeting at 10:00 a.m. Commissioner Buhler, Commissioner Eames, Prosecutor Misseldine and the Chief Deputy Clerk, Jackie Fuqua, were present.

EXECUTIVE SESSION

Commissioner Buhler moved to go into executive session pursuant IC§74-206(b) personnel matters. Roll call vote: Eames-Yes, Buhler-Yes, Bolduc-Yes. The Board recessed the executive session at 10:28 a.m. Commissioner Eames made a motion to temporarily change the status of Chief Deputy Clerk Jackie Fuqua to Acting County Clerk at \$42.78 per hour, 40 hours a week as an exempt employee, until County Clerk Denise Gill comes back or a new clerk is appointed. Commissioner Buhler seconded the motion. Motion carried.

1000 SPRINGS REALTY-LOT LINE ADJUSTMENT

Commissioner Bolduc abstained due to a potential conflict of interest. Grant Cooke from 1000 Springs Realty requested a lot line adjustment. It was pointed out by Prosecutor Misseldine that the wording of the request was inaccurate, so this decision was tabled for now until proper naming of the request is given by Grant Cooke.

Commissioner Buhler recessed the regular session and opened the Ambulance District meeting at 10:45 a.m.

AMBULANCE DISTRICT

Director Kepler presented purchase or lease options for the second new ambulance. After discussion it was decided not to lease. Commissioner Eames made a motion to purchase the new ambulance for \$297,000. Seconded by Commissioner Buhler. Motion carried. Commissioners asked Director Kepler to check on the title with I.T.D. for the first ambulance so grant funds can be dispersed, and to investigate any avenues to sell the old ambulances in inventory. There was also discussion concerning the request for an estimate extension for the handheld radios presented on March 2, 2026. White Cloud will extend an additional 30 days. Clarification was made that the new radios were just needed as backups or for new hires.

Commissioner Bolduc adjourned the Ambulance District and reconvened the regular session at 11:00 a.m.

PUBLIC HEARING
HAGERMAN FIRE PROTECTION DISTRICT

Commissioner Bolduc, Commissioner Buhler, Commissioner Eames, Prosecutor Misseldine, Chief Deputy Clerk, Jackie Fuqua and Michele McFarlane from Frontier Community Resources were present. John Kepler and Barbara Rivers from the public attended. Michele McFarlane gave a brief synopsis of the \$500,000 Idaho Community Development Block Grant program for purchasing a new Type 1 pumper truck and a new Type 4 brush fire truck. The first truck has been received, and the second should arrive within the next week or two. There must be a repair to the Type 1 pumper and then the Type 4 truck will be sent.

Prosecutor Misseldine will speak with Wayne Chandler to get a new contact to move forward.

PUBLIC COMMENT

Michele McFarlane informed the Commissioners that Gooding County was awarded a \$5,000 Smiles Grant. Grant funds are reimbursed, so receipts will have to be submitted for funds to be dispersed.
